Licensing Services - Request for Additional License

Purpose

This document is designed to define and illustrate the online process related to 'Request for Additional License'. This document will brief you on how to apply for this service request and what to expect at the different stages in terms of the online interface, the notification emails and text messages as well as the expected output.


Applicability

This document will be applicable to all DMCC member companies with active licenses or companies changing the type of the existing license.

Important Notes

- A DMCC licensed company cannot apply for additional license if the existing license is expired unless there is a submitted request to terminate the existing license.
- In case the company will operate from a new address (physical office space or retail shop), then, the fit-out for the new premises must be completed.
- The company must ensure that their license activity / activities can be carried out on the new / existing property type; where as a retail activity cannot be carried out in an office or a flexi desk.
- Some activities (Single family office, real estate, DGCX, and professional traders) are standalone activities and cannot be carried out with any other activities even if they fall under the same license category.
- Each license should have a separate flexi desk lease. Multiple licenses cannot be carried out under one flexi desk lease.
- DMCC members operating from a physical office can hold more than one license under the same unit.
- DMCC Authority reserves the right to request any additional documents at any stage of the process.


2. Fill in the mandatory requirements of 'New License Details' such as:

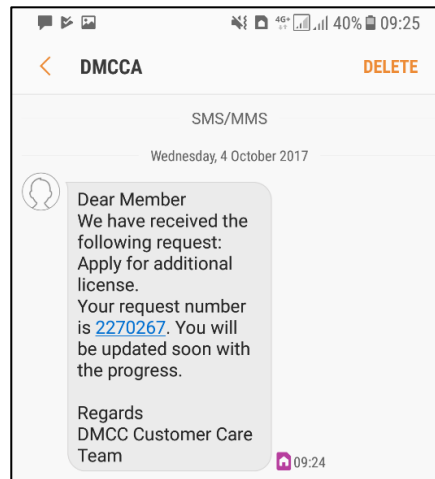
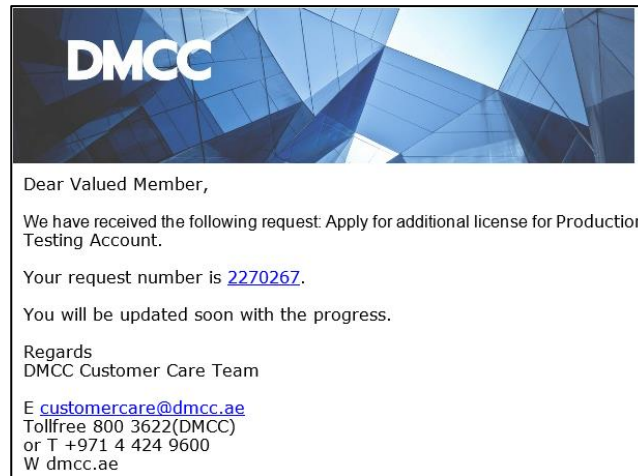

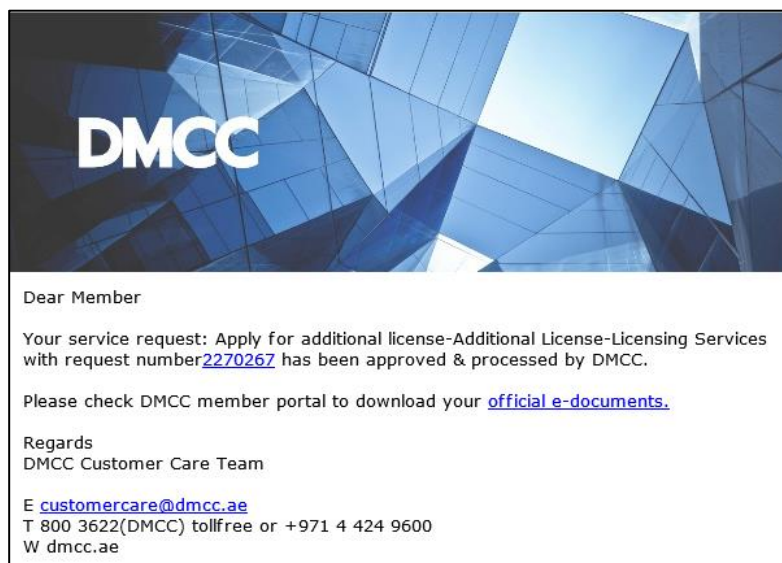
