Introduction

This document is intended to clarify submission requirements and does not need to be submitted to DMCC.

According to the implementing regulations and memorandum and articles of association a DMCC company may request for shisha permit.

Service to Select on Portal

Go to Company Services - Licensing Services - Permits - Apply for shisha permit

Important Notes and Policy

- The Shisha Permit only applies to Restaurants & Coffee Shops.
- The Shisha Permit must be renewed before the expiry of the permit (it may be cancelled if the client no longer wishes to continue).
- The licence must be valid at all times.
- The Retail Annual Operational Certificate (RAOFC) must be valid at all times.
- The DMCC Authority reserves the right to request additional documents at any stage of the process.
- Please refer to the **DMCC Shisha Policy** for a full version of the policy.

Steps

Step 1: Apply for Shisha Permit Service Request.

Step 2: Fill in the fields with your company details and select your shisha permit type (indoor or indoor & outdoor).

Step 3: Upload the Client Acknowledgment Letter and submit the Service Request.

Payment will be deducted as per the selected shisha permit type.

Step 4: DMCC will review the submitted documents and will request concerned team to complete the necessary sight assessment.

Step 5: Once the application is verified, proceed to upload Stage 2 Requirements.

Step 6: Upon the verification of the documents, an Arabic letter to Dubai Municipality (DM) will be generated to take it to DM in order to obtain the DM Shisha Permit.

Step 7: Once obtained, upload the valid shisha permit from Dubai Municipality along with the NOC from Dubai Civil Defense on the service request.

Step 8: DMCC will review the uploaded documents the issue the permit if all documents





are accepted.

Step9: DMCC Shisha permit to be printed and posted outside and within the premises.

Requirements

	A valid DMCC Trade Licence	Licence must be valid upon applying for shisha permit.	
	Client Acknowledgment letter	This is a system-generated letter on the DMCC portal and should be signed by the authorised signatory of the company, stamped and uploaded into the Service Request.	
	Payment	Permit for serving Shisha:- Indoor only: AED 20,035 Indoor & Outdoor: AED 40,035	





Stage 2 (Additional approvals required after the DMCC provisional approval)

Сору	Documents	Remarks
	NOC from the Unit's owner / landlord	No objection letter signed by the unit owner (landlord). If the unit is a joint purchase, all owners must sign the NOC letter.
	NOC from the relevant tower developer or Owners' Association	No objection letter signed and stamped by the tower developer or the Tower's Owners Association.

Output

Upon approval, DMCC shall:

□ Issue an Arabic letter addressed to Dubai Municipality.

	A valid shisha permit obtained from Dubai Municipality	Shisha permit issued by Dubai Municipality upon fulfilling permit requirements
	A valid NOC from Dubai Civil Defense	NOC / approval from Dubai Civil Defense to allow shisha serving
	Fitness Certificate issued by 4See	For any queries related to inspection, please raise a case on the DMCC Help Centre or to reach out to the DMCC Contact Centre.
