Terms and Conditions for Ramadan 2025 Discount Offer

(Terms and Conditions)

1. Definitions

AED means the currency of the United Arab Emirates.

Al Centre Package means the package for a Business License in the DMCC Al Centre available to eligible Applicants pursuant to these Terms and Conditions.

Applicant means an individual making an Application.

Application means an application to DMCCA to avail the Offer and/or a Package by an Applicant.

Authority means any local, regional, territorial, free zone, municipal government, ministry, governmental department, commission, board, bureau, agency, instrumentality, executive, utility provider, judicial or administrative body in the UAE, the Emirate of Dubai or DMCCA.

Basic Biz Package means the original offer launched by DMCCA subject to the terms and conditions available at https://www.dmcc.ae/business-setup-package.

Business License means the renewable license issued by DMCCA allowing the Applicant to conduct business within DMCC Free Zone.

CLG Package means the CLG packages (new and transfer) launched by DMCCA available at https://www.dmcc.ae/business-setup-package.

Company means a registered company maintaining a Business License which is authorised to operate within DMCC Free Zone.

Crypto Centre Package means the existing package launched by DMCCA that is exclusive for crypto businesses setting up in DMCC Free Zone, including but not limited to Companies developing web3, metaverse or blockchain-enabled platforms to firms trading in NFTs and crypto assets.

DMCCA means Dubai Multi Commodities Centre Authority, governed by Law No. (3) of 2020 (as amended) issued in the Emirate of Dubai and situated at P.O. Box 48800, Uptown Tower, Jumeirah Lakes Towers, Dubai, United Arab Emirates and being the governing authority of the DMCC Free Zone.

DMCC AI Centre means DMCC Free Zone AI ecosystem, located at Level 12, Uptown Tower in Jumeirah Lake Towers and which focuses on AI businesses.

DMCC Business Centre means a centre where sharing desks and offices are leased out by DMCCA to Company.

DMCC Crypto Centre means DMCCA cryptocurrency ecosystem located at Level 12, Uptown Tower, Uptown Dubai in DMCC Free Zone, focused on crypto business, including but not limited to Companies developing blockchain- enabled trading platforms to firms offering, issuing, listing, and trading crypto assets.

DMCC Gaming Centre means DMCC Free Zone Gaming ecosystem, located at Level 12, Uptown Tower in Jumeirah Lake Towers which focuses on Gaming and e-sports businesses.

DMCC Free Zone means the free zone of DMCCA, governed by Law No. (3) of 2020 (as amended) issued in the Emirate of Dubai.

First Stage means, in relation to an Application to avail a Package, the creation or submission of the relevant online Application form acknowledging acceptance of these Terms and Conditions in the form prescribed by DMCCA.

Flexi Desk(s) means a Standard Flexi Desk or a Special Desk.

Gaming Package means the original offer launched by DMCCA subject to the terms and conditions available at

https://www.dmcc.ae/business-setup-package.

Jumpstart Package means the original offer launched by DMCCA subject to the terms and conditions available at https://www.dmcc.ae/business-setup-package.

Laws means all legislation, decrees, resolutions, acts, statutes, ordinances, rules or regulations, directives and other orders, treaties, by-laws, codes of practice and other subordinate legislation, of any Authority.

Offer means this offer made by DMCCA to any Applicant subject to these Terms and Conditions as further described in clause 2.

Offer Launch Date means the date on which the Offer was launched by DMCCA being 28th February 2025.

Offer Period means the period of availability of this Offer starting from the Offer Launch Date and ending on 30th March 2025.

Package(s) means all together or any individually the Basic Biz Package, Crypto Centre Package, Gaming Package, Al Centre Package, CLG Package, Jumpstart Package and the Prime Plus Package.

Second Stage means, in relation to an Application to avail a Package, the payment of the Company setup fees, the execution of the Articles of Association (AOA) for the Company and the provision of all necessary documentation as required by DMCCA from time to time following completion of the First Stage.

Special Flexi Desk means the space which DMCCA will allocate for the Business License within one of the DMCC Business Centres for one year and including one visa only, which the Applicant is allowed to use for one hour per month.

Standard Flexi Desk means the desk at one of the DMCC Business Centres which has a validity of one year and is limited to three visas and allows the Applicant to use it four hours per week.

Third Stage means in relation to an Application, the execution of the agreement for a co-working space in in DMCC AI Centre and any other documentation required by DMCCA from time to time further to the completion of the First Stage and the Second Stage for the issuance of the Business License.

UAE means the United Arab Emirates.

VAT means value added tax as defined by Federal Law by Decree No. 13 of 2016 concerning the establishment of Federal Tax Authority.

2. Offer

- 2.1 Subject to clauses 3.9 and 3.10 below, DMCCA shall make the Offer available to any Applicant who makes an Application within the Offer Period, subject to these Terms and Conditions.

- 4.3 Neither DMCC Free Zone and DMCCA, nor any affiliate, officer, director, employee, attorney, or agent of DMCC Free Zone and DMCCA shall have any liability with respect to the Applicant, and the Applicant hereby waives, releases, and agrees not to sue any of them upon, any claim for any special, indirect, incidental, or consequential damages suffered or incurred by the Applicant in connection with, arising out of, or in any way related to, these Terms and Conditions or the Offer.

5. Governing Law and Jurisdiction

5.1 These Terms and Conditions and the Offer are governed by the Laws as applicable in the Emirate of Dubai, UAE and any dispute arising out of or in relation to these Terms and Conditions or the Offer will be subject to the exclusive jurisdiction of the Dubai courts.
